An individual is considered to be in a crisis when they are faced with an event or situation that they deem too big for them to handle due to personal inadequacies and/or limited resources and it exceeds their tolerance capabilities (James & Gilliland 2005, p. 19). Crisis intervention is therefore the immediate help offered by a professional with the objective of helping the persons in crisis – client – to reestablish pre-crisis situation or achieve equilibrium (Echterling et al., 2005).

James and Gilliland (2008) developed a six-step model for crisis intervention. This model focuses on listening and acting in a systematic manner helping people in crisis to regain back to an equilibrium state. The first three steps are focused more on listening while the last three steps are focused on actions.

Gilliland's Six-Step Model, which includes three listening and three action steps, is a useful crisis intervention model. Attending, observing, understanding, and responding with empathy, genuineness, respect, acceptance, nonjudgment, and caring are important elements of listening.

Crisis Interventions

A specific adaption that is representative of this model for crisis intervention is a six-step model proposed by Richard James and Burl Gilliland. In this model, the steps do not necessarily function as discrete entities. Rather, some of the steps may be transposed or they may be integrated as a smoothly flowing process.
